4. Chairmans Report

SP referred members to the detailed report online and said she would just highlight a few points:

Mortlake Community Association's email regarding the impact that the BLS grant has had on their Christmas activities and the list of all those receiving grants during 2023/24.

The membership fee for the year continued at £30, it has been at this level since 2014 and we now propose to increase it to £40 from the beginning of the 2025/26 season. We have increased our annual events to 7, so £40 represents less than £6 per event, most other local author events charge between £10 and £20 an event, the increase will enable us to expand our grant giving activities.

SP thanked the patrons for their support and the trustees who give their time for free and all the institutions around Barnes and Richmond who support the BLS:

Commenting briefly on the accounts, SP said that the BLS delivered a surplus before grants of £4128. After making donations of £4382 in the year the BLS ended with a net deficit of £254. We aim to donate around £4500 a year. Given the strong reserves that we have built

up over recent years we are confident that this level of grant giving is sustainable. Reserves are now standing at £32,351.
