### **5. Chairmans Report**

JW referred members to the report online and said she would just highlight a few points.

2021/22 had been a wonderful season with all events live and back in the church. Membership increased to 364 after the covid dip and fees remained at £30 per person, as for 22/23 and the next season.

JW thanked the Patrons for their support and the Trustees for their hard work. She also paid tribute to Patrick Harvey who died this year. Patrick was a former long standing committee member and treasurer who gave a great deal of time and energy to the BLS.

She also thanked the many institutions who support the BLS including the BCA, Sarah Arthur/The Bugle, St Mary's, Barnes Bookshop, Arts Richmond and all the shops etc.

Commenting briefly on the accounts JW said that there was a healthy increase in income in 21/22, nearly all explained by the lifting of covid restrictions, resulting in reserves of £27,875 in the bank.

The big news of 21/22 was obtaining Charity Commission registration from December 2021 which has made a big difference to the BLS moving forward. In 22/23 there are 396 members, many of whom ticked the gift aid box to enable tax to be claimed back from HMRC.

The BLS can therefore continue to attract great authors as well as promoting literature by supporting a number of organisations and charities in our area with grants.

We have so far this season, 22/23, contributed to the new library at Lowther School, funded a film promoting a Young Writers Award for Arts Richmond, provided books for a book club for young people living in care and funded books for children at the Santa's Grotto in Mortlake.

JW asked the audience to encourage anyone they knew in the area who requires such funding to apply.

No questions were raised on either the report or the accounts.
